AN ORDINANCE AMENDING CHAPTER 15, SECTION 346, OF THE CODE OF THE CITY OF KIRKSVILLE, MISSOURI REGULATING THE PARKING OF MOTOR VEHICLES AND THE DIRECTION OF TRAFFIC OF MOTOR VEHICLES, REGARDING TIME-RESTRICTED PARKING DOWNTOWN.

WHEREAS, a review of the time-restricted parking ordinances downtown, concerns of residents who live in the area, and the current street sweeping schedules employed by the City, determined that the written code contained in Section 15-346 did not accurately reflect current practices/needs; and

WHEREAS, the recommended changes would update the code of ordinances to more accurately reflect the needs of the City and those who live downtown.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF KIRKSVILLE, MISSOURI AS FOLLOWS:

Section 1. Chapter 15, Section-346, of the code shall be amended as follows:

Sec. 15-346. Same—~~2:00~~ **4:00** a.m. to 6:00 a.m. or 12:00 a.m. to 4:00 a.m. or 11:00 p.m. to 6:00 a.m.

(a) Except as otherwise provided in this chapter, it shall be unlawful for any vehicle(s) to be parked in any signed area in the downtown district that prohibits parking ~~between the hours of 2:00 a.m. and 6:00 a.m. on selected days~~, as delineated on posted signs. Any vehicle(s) in violation shall be subject to towing and fine, or a combination of both.

(b) The following streets and times are hereby established as the designated “No Parking” streets and times, referred to in subsection (a). Parking shall be prohibited on the following streets two (2) mornings each week between ~~2:00~~ **4:00** a.m. and 6:00 a.m. on alternating sides of the street as provided on posted signs:

Street List - Delete each reference to ~~2:00~~ a.m. and replace with **4:00 a.m.**

The south and and east sides of streets in the downtown district will be cleared of parking between ~~2:00~~ **4:00** a.m. and 6:00 a.m. on Mondays ~~and Fridays~~. The north and west sides of streets in the downtown district will be cleared of parking between ~~2:00~~ **4:00** a.m. and 6:00 a.m. on Tuesday ~~and Saturday~~ mornings.

(c) It shall be unlawful for any vehicle(s) to be parked in a city parking lot in the downtown district, on selected days, as delineated on posted signs, where parking is prohibited between 2:00 a.m. and 6:00 a.m. ~~In addition, it shall be~~

~~unlawful for any vehicle(s) to be parked in the county parking lot, located on the north side of the Adair County Courthouse on Saturdays between 2:00 a.m. and 2:00 p.m. only through the months of May through October. Any vehicle in violation shall be subject to towing and fine or a combination of both.~~

Section 2. Effective Date

The modifications to this ordinance shall be effective from and after its date of passage.

Section 3. Incorporation into the City of Kirksville Code of Ordinances

The provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the City of Kirksville, Missouri as an addition or amendment thereto.
