AN ORDINANCE AMENDING CHAPTER 19, ARTICLE III, OF THE CODE OF THE CITY OF KIRKSVILLE, MISSOURI REGULATING FOREST LAKE BOAT REGISTRATION FEES.

WHEREAS, funds from City registration fees, governing boat registration at Forest Lake, are expected to assist, at least in part, with provision of City/police services: and

WHEREAS, the current fees have not been increased since at least 1997: and

WHEREAS, the City Council has made a decision to increase the fees.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF KIRKSVILLE, MISSOURI AS FOLLOWS:

- <u>Section 1</u>. Chapter 19, Section 19-71 of the City Code is amended as follows:
 - (a) The city is authorized to charge an annual boat registration fee as follows:
 - (1) All motors and boats with 0 to 20 hp: Ten dollars (\$10,00) <u>Fifteen dollars (\$15.00);</u>
 - (2) All motors and boats with 21 to 40 hp: Fifteen dollars (\$15.00) Twenty-five dollars (\$25.00);
 - (3) All motors and boats with 41 to 65 hp: Twenty Dollars (\$20.00) Thirty-five dollars (\$35.00):
 - (4) All motors and boats with 66 to 90 hp: Twenty-five dollars (\$25.00) Forty-five dollars (\$45.00).

A decal bearing the city permit number and year shall be placed on the port side of the transom of all boats so registered.

- (b) The city is authorized to charge a daily boat registration fee as follows:
 - (1) All motors and boats with 9 to 20 hp: Two dollars (\$2.00) Three dollars (\$3.00).
 - (2) All motors and boats with 21 to 40 hp: Three dollars (\$3.00) Five dollars (\$5.00).
 - (3) All motors and boats with 41 to 65 hp: Four dollars (\$4.00) Seven dollars (\$7.00).
 - (4) All motors and boats with 66 to 90 hp: Five dollars (\$5.00) Nine dollars (\$9.00).

Section 2. Effective Date

The modifications to this ordinance shall be effective from and after its date

passage.
