A RESOLUTION AUTHORIZING RANDY BEHRENS, FIRE CHIEF TO APPLY FOR THE ASSISTANCE TO FIREFIGHTERS GRANT (AFG).

WHEREAS, the Federal Emergency Management Agency awards to fire departments, grants to enhance their ability to protect the public and fire service personnel from fire and related hazards; and

WHEREAS, all funding priorities for the Fiscal Year 2011 AFG are designed to address first responder safety, enhancing national capabilities, risk and/or interopability; and

WHEREAS, there are five different fundable activities in the program to include training, equipment, and Personal Protective Equipment (PPE); and

WHEREAS, the importance of National or State certification training, statutory or Occupational Safety & Health Administration (OSHA) compliance, National Incident Management System (NIMS) and/or Incident Command System (ICS) to maintain compliance with national standards; and

WHEREAS, the purchase of equipment that supports a department's existing mission or that replaces used or obsolete fire equipment and brings a department up to a State or local standard and provides training on that equipment; and

WHEREAS, the grant application must be submitted by 5:00 p.m, EST, on September 9th, 2011; and

NOW, THEREFORE, BE IT RESOLVED that the City of Kirksville hereby requests that Randy Behrens, Fire Chief, apply for the 2011 Assistance to Firefighter Grant (AFG).

AN ORDINANCE LEVYING TAXES AND ESTABLISHING PROPERTY TAX RATES
FOR CITY PURPOSES FOR FISCAL YEAR 2011.
